- The job opening was made available to the Sound of Life Radio Network Listeners. Announcements were aired 5 times per day over the radio network from May 10, 2018 – June 12, 2018.
- 4. The station received two applicants from the outside recruitment sources.
- 5. During the reporting time there were a total of 16 applicants, and of those applicants, six people were interviewed for the vacancy. One of the individuals interviewed heard about the vacancy through one of the outside sources and the others heard about it through the radio station's on-air announcements.
- 6. The following is a list and brief description of the recruitment and job training programs that have been initiated by the Sound of Life.
 - a. Establishment of an internship program designed to assist members of the community to acquire skills needed for broadcast employment. During the reporting period there was one individual participating in the internship program.
 - b. The staff participates in job training and industry conventions as appropriate to scheduling and availability. Membership in two broadcasting organizations provides monthly webinars for staff enrichment and education.
